- Background information on the specific case
- The time constraints for the bond (when the bond is needed, and will it be preliminary, temporary or permanent)



### REQUIREMENTS FOR FIDUCIARY BONDS

Personal Representative | Representative Payee | Conservatorship | Guardianship | Power of Attorney | Trustee | Supplemental Needs Trust | Special Needs Trust

- A bond application
- Credit and background checks for the principal (the person applying for the bond)
- Court order confirming the appointment and relating court documents
- Specifics of the will/trust and the probate case



#### REQUIREMENTS FOR APPEALS BONDS

General Court Appeals | Certiorari | Supersedeas

- A bond application
- A copy of the court order for the bond
- The details and documents of the case being appealed
- The financial amount of the judgement
- The case for the appeal
